

- Allegany County
- Cecil County
- Frederick County
- Garrett County
- Harford County
- Southern MD: Calvert, Charles & St Mary's Counties
- Washington County

Maryland Department of Housing & Community Development serves as the:

- CoC Lead Agency meaning DHCD is responsible for conducting planning activities for the CoC
- Collaborative Applicant meaning DHCD submits the CoC grant to HUD on behalf of the CoC

ICA administers the HMIS – meaning they are in charge of administering the HMIS database per HUD regulation



CoC Funding Competition

Each year, HUD publishes the Continuum of Care Notice of Funding Opportunity for CoC's to apply for renewal and new project funding to support projects designed to end homelessness for individuals and families

The NOFO:

- Specifies the amount of funds CoCs are eligible to apply for
- Prescriptive process: must have clear policies, meet set deadlines, adhere to public notification requirements
- Provides Policy Priorities to guide communities in appropriate project design
 and selection

CoC Funding Competition Requirements

- CoCs are required to facilitate a local competition to identify projects to be included in the Coc application to HUD and to determine the order of priority of the projects
- The competition must identify how it will review, score and rank project applications from across the CoC that will be recommended for funding to HUD
- The Balance of State has established a process to accept new & renewal project applications, how the applications will be scored, determine if they will be accepted or rejected and what priority order the projects will be ranked

- Official Committee of the BoS CoC Board of Directors
- BoS response to the HUD requirement to

"use objective, performance-based scoring criteria and selection priorities that are approved by the CoC to determine the extent to which each project addresses HUD's policy priorities"

 Will facilitate the project scoring, selection, rating and ranking process for FY2024 CoC Funding Competition



Performance Review Committee

Committee Membership Includes:


- At least one representative from each of the Local Homelessness Coalitions
- Representatives from the State Agencies participating on the CoC Board of Directors
- Individuals with Lived Experience with homelessness
- Who do not present a conflict of interest in the determination of funding decisions



Performance Review Committee Duties

- Read new project application submissions and score based on the provided criteria
- Review renewal project pre-populated scorecards and take note of any additional comments provided by the applicant related to specific performance targets
- Rank projects in priority order based on the CoC Policy and make funding adjustments as needed
- Submit final project priority listing to the CoC Board of Directors for final review





CoC Notice of Funding Opportunity

- Deadline October 30, 2024
- The BoS CoC is eligible to apply for up to \$8,442,716
 - Renewal Projects: \$7,050,242
 - New Project Bonus Opportunity Funding: \$846,030
 - Domestic Violence New Project Bonus Opportunity Funding: \$546,444



CoC Program Projects

- Permanent Supportive Housing (PSH) permanent, open ended housing assistance and services to people experiencing homelessness and have a disability; typically targets Chronically Homeless
- Rapid Rehousing (RRH) housing without a designated length of stay with short- or medium-term rental assistance and services for people experiencing homelessness
- Joint Transitional Housing / Rapid Rehousing (TH-RRH) combines the Transitional and Rapid Rehousing components
 - * Supportive Services Only: Coordinated Entry
 - * Homeless Management Information System (HMIS)
 - * CoC Planning



2024 HUD Policy Priorities

- 1. Ending homelessness for all persons.
- 2. Use a Housing First approach.
- 3. Reducing Unsheltered Homelessness.
- 4. Improving System Performance.
- 5. Partnering with Housing, Health, and Service Agencies.
- 6. Racial Equity.
- 7. Improving Assistance to LGBTQ+ Individuals.
- 8. Persons with Lived Experience.
- 9. Build an Effective Workforce.
- 10. Increasing Affordable Housing Supply.

Ranking & Tiering

- CoCS are required to rank all new and renewal project applications in priority order based on CoC policy which may include local priorities, needs and gaps
- HUD also encourages project funding reallocation from lower performing projects to new higher performing projects
- Ranked projects will fall into two tiers
 - Projects in Tier 1 likely to receive funding assuming threshold approval
 - Projects in Tier 2 are subject to additional scoring and compete nationally based on CoC Performance and rank order

Ranking Policy

Project Rank Order

Projects will be ranked based on component type, in order of highest to lowest score.

- 1. Renewal permanent supportive housing projects, ranked in order of highest to lowest percentage score
- 2. Renewal rapid rehousing projects, ranked in order of highest to lowest percentage score
- 3. Renewal Joint TH-RRH, ranked in order of highest to lowest percentage score
- 4. First time renewals that do not have a full year of project performance: PSH, RRH, Joint TH-RRH
- 5. Renewal SSO-CE projects that are not dedicated to the full BoS CoC geography
- 6. New CoC Bonus projects based on committee score of RFP responses
- 7. New DV Bonus projects based on committee score of RFP responses

As HMIS and Coordinated Entry are HUD mandated activities, these projects will be placed in Tier 1 to secure the funding needed for these activities. The CoC Planning Grant is noncompetitive and is not a ranked project in this competition.

Committee has the authority to make needed adjustments to the rank order due to geography, special populations, voluntary reallocation or other CoC identified priority areas.

Ranking Policy Adjustments

Renewal Project Score Threshold

All scored renewing projects are subject to an eligibility threshold. Projects that score in the lowest 20% of all renewal projects may be moved to a lower ranking status and may be subject to reallocation. For example, the Performance Review Committee may rank a new project above a renewing project that scores in the bottom 10%.

Geography

HUD has determined that geographic diversity is an appropriate consideration in selecting homeless assistance projects in the CoC competition. Likewise, MD-514 recognizes that geography is an appropriate consideration for the competition. Projects may be ranked higher to ensure CoC funded programs are accessible to people experiencing homelessness throughout the entire MD-514 geography.

Vulnerable and High-Needs Populations

MD-514 recognizes that high quality projects serving vulnerable and high-needs populations, such as chronic homelessness, domestic violence and substance abuse; are a critical component to ending homelessness. The Performance Review Committee may rank the projects higher to ensure the programs are prioritized to receive CoC funding. These programs must meet a need in the community, show positive housing related outcomes and provide choice to participants seeking the services offered.

Voluntary Reallocation

Projects that choose to voluntarily reallocate at least 50% of their current grant amount in order to apply for a new reallocation-based project may be granted additional consideration in the ranking order. Projects that elect to fully reallocate their grant in order to change project component types, a Transition Grant, will be included in this scenario.

Funding Leverage

In alignment with the HUD CoC NOFO priorities, PSH and RRH project applications that demonstrate a commitment to leverage housing and/or health care system resources may be considered for a higher placement in the ranking order.



Reallocation Policy

Policy allows for two types of reallocation:

- 1. Voluntary Reallocation Individual projects may request to reallocate all or part of their current funding for various reasons, including difficulty spending the full grant, project performance or to create a transition grant. These projects may receive additional consideration in the ranking order.
- 2. Involuntary Reallocation Renewal projects may have funds reallocated by the Performance Review Committee due to poor project performance, spending history with consistent high rates of recapture, or failure to meet HMIS participation requirements.
