



State Funding Updates

COVID19 Emergency Solutions Grant (ESG-CV)

- ESG-CV2 grant agreements and application/budget templates were sent out to LHCs – due back end of March
- No additional ESG-CV funding expected at this time

Homelessness Solutions Program (HSP)

- FY22 application process and timeline will be announced soon goal is to have grant agreements in place by July 1
- Expect minimal application and to flat-fund LHCs/CoCs- no competitive aspect to normal HSP funds (youth funds may look different)
- DHCD will be convening LHC board representatives to discuss FY22 process and the grant administration needs of LHC pass-through organizations

- BoS areas will be awarded up to \$30,882,611 in first round (\$193m statewide)
- Additional ERAP funds will be awarded later
- Up to 8% of funds can be used on administrative costs and housing stability services
- Application released to counties March 17, due back April 2
- Counties accepting tenant applications no later than May 1 (many will start earlier)
- Counties may subgrant funds to local partner agencies

State RELIEF Act Funds

Emergency Housing - \$15 million statewide

- Will be granted to all Maryland CoC/LHC lead agencies
- 100% of funds advanced to CoCs/LHCs by June 30, 2021
- Funds can be subgranted to local partner agencies
- Eligible activities include sheltering (congregate shelter and hotel/motel) as well as rental assistance (paid out 30 days at a time)
- Admin is allowable (% to be determined) and shareable with local partners
- Details to follow

Other New Federal Funds

American Rescue Plan Act (enacted March 11)

- ERAP 2 \$21.55 billion expansion
- HOME \$5 billion (includes capital funding!)
- Housing Choice Vouchers \$5 billion
- LIHEAP (\$4.5 billion) and Water Assistance (\$500 million)
- Homeowner Assistance \$9.96 billion

New ERAP, HOME, Voucher resources generally limited to households who:

- (1) are or are at risk of experiencing homelessness
- (2) are fleeing or attempting to flee domestic violence, dating violence, stalking, sexual assault, or human trafficking, or
- (3) are recently homeless and assistance will prevent the family's homelessness or having a high risk of housing instability

2020-2024 Consolidated Plan

- Draft will be released soon (COVID delayed)
- DHCD will be seeking input from CoCs/LHCs on 5-year funding priorities for ESG, HOME, CDBG, and HOPWA
 - Feedback during this Friday's COVID19 call prior to draft plan release
 - Formal public comment period after draft plan release

COVID19 Response

Vaccinations

- Congregate living facilities are in vaccine group 1B (which is open now)
- Starting to track data on shelter vaccinations and unsheltered vaccinations via statewide tracking tool
- Reported challenges with getting vaccine clinics set up at homeless shelters through local health departments
- DHCD is escalating issues to MDH as they are reported
