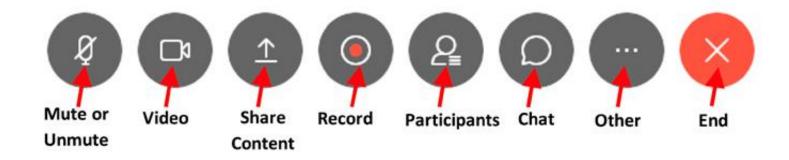

- HUD CoC NOFA: Team HMIS working with CoC Lead and all projects for scoring, data quality, and collaborative application
- **New Western MD Veteran BNL Meetings**: 10/12, 1:00pm (Allegany Co, Garrett Co, Washington Co)
- **Upcoming Quarterly HMIS User Forum**: 10/18, 10:30am (3rd Monday every 3 months)

## System Performance Key Take Away

- People of color are overrepresented in the BoS system as compared to the general population
- People of color experience worse outcomes than white counterparts in every measure reported
- Poor data quality is impacting outcomes and ability to accurately measure performance
- Next Steps:
  - Quarterly performance reports: to measure progress over time
  - Increased efforts in the Data Quality Management Plan

## Harford County CoC Merge

- April 2021: Harford County CoC expressed interest in learning about joining the Balance of State
- April May 2021: Preliminary meetings have been held with the Harford County CoC Board, the BoS Executive Committee, Lead Agency, TA Providers and HUD
- June 2021: Harford County CoC Board voted to approve the merge
- July 2021: The BoS Board voted to approve the merge, HUD has approved
- Fall 2021: DHCD to continue to coordinate with HUD, Harford, TA to finalize HMIS, reporting requirements, LHC representatives & orientation

# **Funding Updates**

## **CoC NOFA New Project Opportunities**

#### **CoC Bonus Funding**

- \$220,905
- Must be one of the following
  - Permanent housing-permanent supportive housing (PH-PSH) projects that serve persons who meet the definition of DedicatedPLUS or persons experiencing chronic homelessness at the time of initial enrollment
  - New PH-RRH, Joint TH and PH-RRH, and Coordinated Entry SSO projects may serve persons who qualify as homeless under paragraphs (1), (2), or (4) of 24 CFR 578.3
  - **Dedicated HMIS** project that can only be carried out by the HMIS Lead

#### **DV Bonus Funding**

- \$260,693
- New projects that want to be considered for the DV Bonus, must be:
  - Dedicated to serving survivors of domestic violence, dating violence, sexual assault, or stalking that are defined as homeless
  - Rapid Rehousing or Joint TH and PH-RRH component projects that demonstrate traumainformed, victim-centered approach and follow a housing first approach
  - **SSO for Coordinated Entry** to implement policies, procedures, and practices that equip the CoC's coordinated entry to better meet needs of survivors of domestic violence, dating violence, sexual assault, or stalking
